

WTTS Back Together Barbecue VIP Room Contest

1. How to Enter the Contest:

a. The WTTS Back Together Barbecue contest will have three (3) official rounds. These will begin and end as follows: Contest 1 will begin on June 1, 2020 at 6:00am EST and end on June 30th at 11:59pm EST. Contest 2 will begin on July 1st at 12:01am EST and end on July 31st at 11:59pm EST. Contest 3 will begin on August 1st at 12:00am EST and end August 30, 2020 at or around 11:59pm EST.

b. To participate listeners will head to <http://wttsfm.com/welcome-to-the-92-3-vip-room/>, click on the contest labeled "WTTS Back Together Barbecue" and enter their email address.

2. Eligibility Restrictions:

a. The contest is open to all WTTS listeners who are 21 years of age or older and who reside in the greater Indianapolis and outlying areas. Employees of WTTS, Sarkes Tarzian, Inc., participating sponsors/promotional partners, other radio stations in the Indianapolis metropolitan area and the members of their immediate families are ineligible to participate or win. Immediate family members are parents, children, spouses, those in spouse-like relationship, and siblings (including those in step- and half-relationships when living in the same household).

b. Eligible participants can win a WTTS contest only once every thirty days and a prize valued at \$600 or more only once every six months. Only one winner per household is permitted in any contest. Contestants may enter the WTTS Back Together Barbecue once each month the contest is running (June, July, August) unless they have already won a WTTS prize in the last 30 days.

Prize (c) may be picked up at either W. 96th Street on the Northside of Indy & Greyhound Pass in Carmel. Prizes (d-h) may be picked up at the office of WTTTS: 407 Fulton Street, Suite 220, Indianapolis, IN. 46202 by appointment. Any prize or prize certificate not claimed within 5 days of initial contact with winner will be forfeited by the winner. If any prize or prize certificate is forfeited, an alternate winner will be selected. WTTTS is not responsible for the safe arrival of a prize or prize certificate.

j. Contest prizes are not transferable. Prizes may not be substituted for or redeemed for cash.

4. Selection of Winners:

a. Decisions of station management with respect to the contest are final.

b. Winner will be selected on or around June 30, July 31, and August 30, 2020 by the follow method: One finalist will be selected by random drawing from the WTTTS Back Together Barbecue contest to determine the Grand Prize Winner each month.

c. Winner need not be present to win; once the winner is chosen, they will be notified by WTTS by phone and email. If the winner cannot be contacted within 5 days after the prize winner is selected, an alternate winner will be selected.

5. Conditions:

a. Payment of all federal, state and local taxes is the sole responsibility of the winner. Winners will be reported to the IRS on IRS Form 1099 or the equivalent.

b. By participating in the contest, the winner or winners (and their guest or traveling companion, if any) agree to allow their name, voice, and/or likeness to be used in any advertising or broadcasting material relating to this contest for a period of one year without additional financial or other compensation.

c. Contest winners are required to sign a Receipt verifying eligibility prior to acceptance of any prize of more than nominal value. Before claiming a prize, contest winners (and each of their guests or traveling companions, where applicable) are also required to sign a Liability Release and/or Travel Release if the prize to be awarded is valued at \$600.00 or greater, if the contest or the prize entails dangerous or potentially dangerous activity, or if the prize includes the provision of transportation, whether or not such transportation is provided by WTTS. The station further reserves the right to cancel, terminate or modify the contest if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.

6. These rules are subject to the interpretation of WTTS. Any aspect of these rules, including the substitution of a prize or prizes of equivalent or greater value, can be changed at the discretion of WTTS, and such change(s) will become effective upon on-air or other appropriate announcement.

7. No purchase is necessary. The contest is void where prohibited.

8. Failure to comply with the contest rules may result in a contestant's disqualification, at the sole discretion of WTTS.

9. WTTS is not responsible for typographical or other errors in the printing, the offering or the administration of the contest or in the announcement of any prize.
