- 1. How to Enter the Contest:
- a. The WTTS GuitarWorks contest will begin on November 26th, 2018 at 7:30am EST and end on December 23, 2018 at 8:59am EST, four total weeks (the "contest period.") b. To participate in the contest, listen each weekday morning to the Morning Music Mindbender at 7:35am EST. The first caller to correctly answer a music trivia question will win a qualifying prize, and be entered into a random drawing amongst that week's qualifying prize winners for the weekly grand prize. Every Friday morning during the contest period, a grand prize winner will be drawn from the qualified winners from that week's qualifiers.
- 2. Eligibility Restrictions:
- a. The contest is open to all WTTS listeners who are 18 years of age or older and who reside in the greater Indianapolis, Bloomington and outlining areas.
