# WTTS Rocking Stocking VIP Room Contest

- 1. How to Enter the Contest:
- a. The WTTS Rocking Stocking contest will have one (1) official round. It will begin and end as follows: Contest will begin on November 27, 2020 at 6:00am EST and end on December 20, 2020 at 11:00pm EST.

## 2. Eligibility Restrictions:
